




#### WARNING!




## 4. Description of function

The prefab module (118545) is a specially adapted accessory to our EcoNordic WH4. It has a mounting plate which is easily mounted on the inside of the installation module, which is fitted with most of what is required before making further installations for the distribution cabinet, heating and domestic water.

The prefab module is service-friendly and includes among other things components to control pressure levels and purity in the system.

The expansion vessel (kit) for domestic hot water (118546) is supplied as a separate accessory.

1	Expansion tank, heating 12 litres
2	Expansion tank, domestic hot water 18 litres
3	Magnetic filter
4	Filling, heating system
5	Coarse filter, domestic hot water
6	Safety valve, heating system
7	Pressure gauge, heating system

9	Bleeding, heating system





## 5. Installation

The product is to be installed on the floor. Install in the following order:

#### 5.1. INSTALLING THE PREFAB MODULE

5.1.1. To open the door






Put the product in service mode and then disconnect the power before service is performed.





#### Service mode

- 1. Start the Flexit GO app and connect to the product you are servicing.
- 2. Go to the service page (Other > Service)
- 3. Select "Service mode". The product will now carry out a controlled shut-down. The time taken may vary according to the operating mode.
- 4. Switch off the all-pole cut-off device. You can now carry out the service.












## 5.3. FITTING THE DOMESTIC HOT WATER PIPE CONNECTIONS






## 5.5. FITTING THE DRAINING HOSE



## 6. Before commissioning

#### Expansion vessel for heating

Before starting to use the system, the starting pressure in the expansion vessel must be adjusted according to EN 12828. The opening pressure of the safety valve is 2.5 Bar.

The CP335-12 expansion vessel is rated for 3 Bar and is delivered with a pressure of 0.5 Bar.

#### Expansion vessel for domestic hot water

The module consists of an expansion vessel for domestic hot water. The pressure rating is 10 Bar, and the pressure is set at the factory at 2.5 Bar. The starting pressure must be adjusted according to EN 12828.

#### Filling/Venting/Check for leaks

Before filling the domestic hot water and heating system. Follow chap. "6. Commissioning" (installation instructions for EcoNordic).

Then begin by opening the valve **1-7** (follow the drawing). Ensure that the pressure is set at 1.5 Bar for the heating system (figure **10**), then close valves **5**. Vent the system through the venting nipple (figure **8**) and safety valve (figure **9**).


Check that the pressure remains at 1.5 Bar after venting. If the pressure level has dropped, it must be filled again: to do this open valves **5** again.

Then check that there are no leaks at the connections. Vent finally by turning on a thread at one of the drawingoff points for hot water in the house.

Flexit gives no guarantee for any leaks that may occur during the filling process.

## 7. Final check

#### Check the following items:

Description	Completed 🗸
Check that the starting pressure for heating expansion is correct. Note this also on the marker label on the expansion vessel, with date and inspector.	
Then check that the starting pressure for domestic hot water is correct. Note this also on the marker label on the expansion vessel, with date and inspector.	
Then check that there are no leaks.	
Then check that the safety valve is not dripping continually.	
Check the filters for both the heating system and incoming cold water (approx. 24 hours after starting up).	



**INFO!** It is important that individual components of the function are not removed; if they are removed, none of the guarantees apply.
